

ATOMIC MASS GAMES ADEPTICON 2026 MINIATURE PAINTING COMPETITION

OFFICIAL RULES

ALL FEDERAL, LOCAL, STATE, AND MUNICIPAL LAWS AND REGULATIONS APPLY.
VOID WHERE PROHIBITED.

1. **ELIGIBILITY:** The Atomic Mass Games Adepticon 2026 Miniature Painting Competition ("Contest") is only open to legal residents of the fifty (50) United States, the District of Columbia and U.S. territories who are at least (14) fourteen years old at the time of entry and who have valid admission to AdeptiCon 2026 in Milwaukee Wisconsin ("Participant(s)"). Participants between the ages of fourteen (14) and seventeen (17) ("Minor") at the time of entry may only participate in the "Destined" category (as defined in Section 3 below), are not eligible to win the trophies, and must provide a parent or legal guardian's signed written permission to enter prior to entry into the Contest. If you are a Minor, one of your parents or legal guardians agrees that they have read, understood, and agree to these Official Rules with your entry, and that such agreement constitutes acceptance of these Official Rules on behalf of you and themselves. For clarity, (a) any parent or legal guardian of a Minor agrees that all references to "you" or "Participant" throughout these Official Rules will include both the parent or legal guardian and the Minor; (b) you represent, agree, and warrant that you have read and understand the Official Rules and are authorized to accept such terms and rules on behalf of both you and the Minor; and (c) in the event you (including the Minor) violate the Official Rules, you agree to be responsible for any such violation. Employees of Asmodee North America, Inc. ("Sponsor"), Marvel Brands LLC, and their respective parent company, subsidiaries, affiliates, suppliers, advertising, studios, and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible to participate. The Contest is subject to federal, state, and local laws and regulations.
2. **AGREEMENT TO OFFICIAL RULES.** Participation in the Contest constitutes Participant's full and unconditional agreement and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon being compliant with these Official Rules and fulfilling all other requirements set forth herein.
3. **CONTEST CATEGORIES AND REQUIREMENTS.** Each Participant over the age of eighteen (18) may enter painted *Marvel: Crisis Protocol* miniature models ("Models") one (1) time in as many of the following categories ("Contest Category") as they choose:
 - Single Miniature: one (1) *Marvel: Crisis Protocol* character miniature; entire entry size not larger than 120 mm. wide by 120 mm. deep by 150 mm. high.
 - Duel: a scene featuring two (2) *Marvel: Crisis Protocol* character miniatures; entire entry size not larger than 200 mm. wide by 200 mm. deep by 220 mm. high.
 - Squad: three (3) to six (6) *Marvel: Crisis Protocol* character miniatures; entire entry size not larger than 300 mm. wide by 300 mm. deep by 300 mm. high.

Each Participant who is a Minor may submit one (1) Entry in the following category:

- Destined Open Category: one (1) *Marvel: Crisis Protocol* character miniature; entire entry size not larger than 120 mm. wide by 120 mm. deep by 150 mm. high.

All Participants in all categories must follow the guidelines listed below in order to be eligible to win a prize in one of the categories:

- All Models must consist of official *Marvel: Crisis Protocol* character miniatures, which will not be provided to Participants. Any Models containing conversions must consist of fifty-one percent (51%) or more of *Marvel: Crisis Protocol* miniatures. Any Models containing conversions must be composed entirely of *Marvel: Crisis Protocol* miniature parts and/or scratch-built parts.
- All Models must be painted by the Participant entering the Contest.
- All Models must be identifiable as the character they represent.
- All Models must not bear likeness to any person(s) living or dead.
- All Models must encapsulate the *Marvel: Crisis Protocol* atmosphere and narrative.

- Models may not include elements of other intellectual property or license(s) including, but not limited to, sports teams, cartoon characters, and products.
- Models can include scratch-built terrain, resin bases, and hobby miniature terrain accessories produced by third-party companies who do NOT also produce and/or market tabletop miniature games. This can include, but is not limited to, grass tufts, flock, pre-made trees, resin terrain, and brass etched parts.
- All Models must be mounted on a scenic base interacting with a detailed environment. This display base may be a decorative base, or plinth, or appropriately sized *Marvel: Crisis Protocol* base

4. **ENTRY PERIOD & HOW TO ENTER.** Entries can be submitted starting on or about 10:00:00 AM (CT) on March 25, 2026 and ends at 12:00:00 PM (CT) on March 28, 2026. Participants must enter the Contest by submitting their Models and filling out and submitting the entry form ("Form") at the Atomic Mass Games booth in Hall C at Adepticon 2026. The Form must be legible and completed in full. Participants that do not provide complete Models or Form or who do not adhere to the rules or specifications in these Official Rules may be disqualified at the sole discretion of Sponsor. If a Participant uses fraudulent methods or otherwise attempts to circumvent the rules, that Participant's entry may be removed from eligibility at the sole discretion of Sponsor.

5. **PICKUP OF MODELS AT CLOSE OF CONTEST.** At the time of entry, each Participant will receive a number with a corresponding ticket. At the conclusion of the Contest, all entries must be collected from the Atomic Mass Games display area between the times specified and posted at AdeptiCon 2026. To collect Models, Participants must present the correct corresponding ticket, as described in this section, and valid identification in person. Unclaimed Models will become property of Sponsor.

6. **PRIZES & ODDS.** Each Participant will receive one (1) commemorative patch (ARV: \$2.00 USD each). Entries in each Contest Category may be awarded a commemorative gold, silver, or bronze coin (ARV: \$7.00 each) based on criteria set forth below. One (1) Mjolnir trophy (ARV: \$200.00) is available to win in each Single Miniature, Dual, and Squad Contest Category. The winner in each category will be chosen from the entries that received gold coins, if any, from each eligible Contest Category. If there are no entries eligible in a Contest Category, no Mjolnir trophy will be awarded in that category. One (1) All-Father Odin trophy (ARV: \$300.00) will be awarded to one of the Mjolnir trophy winners. If there are no Mjolnir trophy winners, the All-Father Odin trophy will not be awarded.

Actual/appraised value may differ at time of prize award. The prize(s) and the specifics of the prize(s) will be solely determined by Sponsor. No substitution of prize(s) or transfer/assignment of prize(s) to others or request for the cash equivalent by winner(s) is permitted, except at Sponsor's sole discretion. Any difference between stated approximate retail value and actual value will not be awarded. Sponsor reserves the right to substitute any portion of the prize with a prize of equal or greater value. All costs, taxes, fees, and expenses associated with any element of the prize not specifically addressed in these Official Rules are the sole responsibility of the winner. Winner will be issued a 1099 tax form for the actual retail value of the Prize, if required. Acceptance of prize(s) constitutes permission for Sponsor and its affiliates, subsidiaries, and parent company to use the winner's name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law. Odds of winning depend on the total number of eligible entries received. Unclaimed or undeliverable prizes will not be awarded. Prize consists of only the items specifically listed as the prize.

7. **WINNER SELECTION AND NOTIFICATION.** The Contest is a contest of skill. Winning entries in each category will be selected by a panel of judges from among all eligible entries in such category on March 28, 2026 at or about 6:00:00 PM (CT). Entries will be judged by the following criteria: Composition, Creativity, Consistent Quality, Storytelling, and Technical Aptitude. Not all Participants will win a coin or trophy. All Participants will receive a commemorative patch

Sponsor will announce the winner(s) in each category on March 29, 2026 at or about 11:00:00 AM (CT) at the Atomic Mass Games booth at Adepticon 2026. Winners will be notified in person or via phone call. If any potential Prize winner is found to be ineligible, or if he, she, or they have not complied with these Official Rules, declines the Prize(s) for any reason prior to award, or fails to attend the award ceremony, such Prize will be forfeited, and an alternate prize winner may be selected at Sponsor's discretion. The receipt by the winner of the prize offered in the Contest is conditioned upon compliance with any and all federal and state laws and regulations. ANY VIOLATION OF THESE OFFICIAL RULES BY WINNER (AT SPONSOR'S SOLE DISCRETION) WILL RESULT IN SUCH WINNER'S DISQUALIFICATION AS WINNER OF THE CONTEST(S) AND ALL PRIVILEGES AS WINNER WILL BE IMMEDIATELY TERMINATED.

8. **RIGHTS GRANTED BY YOU.** By entering the Contest, you understand that Sponsor, anyone acting on behalf of Sponsor, or its respective licensees, licensors, successors, and assigns will have the right, where permitted by law, without any further notice, review or consent to print, publish, broadcast, distribute and use, worldwide in any media now known or hereafter in perpetuity and throughout the World, your entry, including, without limitation, the entry and winner's name, portrait, picture, voice, likeness, image or statements about the Contest, and biographical information such as news, publicity or information and for trade, advertising, public relations, marketing and promotional purposes without any further compensation.
9. **GENERAL TERMS AND CONDITIONS.** Sponsor reserves the right, at its sole discretion, to cancel, terminate, modify, or suspend the Contest should, in its sole discretion, non-authorized human intervention, fraud or other causes beyond its control corrupt or affect the administration, security, fairness or proper conduct of the Contest. In such a case, Sponsor may select recipients from all eligible entries received prior to and/or after (if appropriate) the action taken by Sponsor. Sponsor reserves the right at its sole discretion to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Contest or violates these Official Rules.

11. **LIMITATION OF LIABILITY/RELEASE.** By entering, you agree to release and hold harmless Sponsor, Marvel Brands LLC and their subsidiaries, affiliates, advertising and promotion agencies, partners, representatives, agents, successors, assigns, employees, officers, and directors from any liability, illness, injury, death, loss, litigation, claim, or damage that may occur, directly or indirectly, whether caused by negligence or not, from: (i) such Participant's participation in the Contest and/or his/her acceptance, possessions, use, or misuse of any prize or any portion thereof; (ii) technical failures of any kind, including but not limited to the malfunction of any computer, cable, network, hardware, or software, or other mechanical equipment; (iii) the unavailability or inaccessibility of any transmissions, telephone, or Internet service; (iv) unauthorized human intervention in any part of the entry process or the Contest; (v) electronic or human error in the administration of the Contest or the processing of entries.
12. **DISPUTES.** The Contest is governed by the laws of the United States of America and the State of Minnesota, without respect to conflict of law doctrines. Further, in any such dispute, under no circumstances will participant be permitted to obtain awards for, and hereby waives all rights to claim punitive, incidental, or consequential damages, including reasonable attorneys' fees, other than participant's actual out-of-pocket expenses (e.g.: costs associated with entering the Contest, if any), and participant further waives all rights to have damages multiplied or increased.
