OFFICIAL RULES

1. **HOW TO ENTER:** The Fantasy Flight Games Twilight Imperium 25th Anniversary Social Media Sweepstakes (“Sweepstakes”) is an online-only Sweepstakes. Sweepstakes begins at 10:00:00 AM (CT) on November 25, 2022 and ends at 11:59 PM (CT) on November 27, 2022 (this is the “Promotion Period”). To enter, eligible entrants must comment on the Sweepstakes Facebook, Instagram or Twitter Sweepstakes announcement (“Entry”).

All Entries become the property of Sponsor. Limit one (1) Entry per person, across all three (3) social media platforms during the Promotion Period. Any entrant who attempts to enter more than once for the Promotion Period using multiple Facebook, Instagram, or Twitter accounts, or under multiple identities will be disqualified from participation in the Sweepstakes and all Entries from that individual will be considered void. Proof of submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for any change of Facebook, Instagram, or Twitter account status, email address, and/or telephone number of entrants.

3. **ELIGIBILITY:** Open to legal residents of the fifty (50) United States and District of Columbia who are 18 years of age or older at time of Entry who are registered members of Facebook, Instagram and/or Twitter. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within forty-eight (48) hours of the first notification attempt, such potential winner will forfeit their prize and an alternate

winner may be selected. Sponsor, in its sole discretion, will attempt to contact up to four (4) potential winners of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed. If any potential prize winner is found to be ineligible, or if he, she or they have not complied with these Official Rules or declines the prize for any reason prior to award, such prize will be forfeited, and an alternate prize winner may be selected.
