

FANTASY FLIGHT GAMES USA LIVESTREAM SWEEPSTAKES
APRIL 20th, 2022
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. YOU MUST HAVE INTERNET ACCESS TO ENTER. SWEEPSTAKES IS IN NO WAY SPONSORED, ENDORSED, ADMINISTERED BY, OR ASSOCIATED WITH YouTube, INC.

1. **HOW TO ENTER:** The Fantasy Flight Games Livestream Sweepstakes (“Sweepstakes”) is an online-only Sweepstakes. Sweepstakes begins at 1:00:00 PM (CT) on April 20, 2022 and ends at 2:00:00 PM (CT) on April 20, 2022 (this is the “Promotion Period”). To enter, eligible entrants must comment on the Sweepstakes Livestream (while it is live) with their relevant response (“Entry”).

All Entries become the property of Sponsor. Limit one (1) Entry per person for the Promotion Period. Any entrant who attempts to enter more than once for the Promotion Period using multiple YouTube accounts, or under multiple identities will be disqualified from participation in the Sweepstakes and all Entries from that individual will be considered void. Proof of submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for any change of YouTube account status, email address, and/or telephone number of entrants.

2. **PRIZE(S):** One (1) lucky winner will receive the prize listed below:

3. **ELIGIBILITY:** Open to legal residents of the fifty (50) United States and District of Columbia who are 18 years of age or older at time of Entry who are registered members of YouTube. Employees of Fantasy Flight Games (“FFG”), its parent company, affiliates, subsidiaries, partners, advertising and promotion agencies (collectively, “Promotion Entities”) and their immediate family members and/or those living in the same household of each are not eligible to participate. All federal, state and local laws and regulations apply. Void where prohibited. No Entry may contain the image or images of any minor(s).

4. **WINNER SELECTION:** One (1) winner will be selected in a random drawing to be conducted on or about April 20th, 2022, from among all eligible Entries received during the Promotion Period by the judges in this Sweepstakes, whose decisions are final and binding.

5. **WINNER NOTIFICATION:** Potential prize winner(s) will be notified initially by message in the livestream chat. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within twenty-four (24) hours of the first notification attempt,

such potential winner will forfeit their prize. Sponsor, in its sole discretion, will attempt to contact up to a potential winners of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed. If any potential prize winner is found to be ineligible, or if he, she or they have not complied with these Official Rules or declines the prize for any reason prior to award, such prize will be forfeited, and an alternate prize winner may be selected.

6. PRIZES/APPROXIMATE RETAIL VALUES (ARV)/ODDS: One (1) winner will receive one copy of (1) each: *The Fractured Void*, *The Necropolis Empire*, and *The Veiled Masters*. The ARV of the prize is fifty-one dollars (\$51.00). Odds of winning depend on total number of eligible Entries received. Unclaimed prizes will not be awarded. An "*authorized account holder*" means the natural person who is assigned to an e-mail address by an Internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. A potential winner may be required to provide ANA with proof that a potential winner is the authorized account holder of the account associated with the winning Entry.
