

2024 Marvel Champions Campaign Contest

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. YOU MUST HAVE INTERNET ACCESS TO ENTER. CONTEST IS IN NO WAY SPONSORED, ENDORSED, ADMINISTERED BY, OR ASSOCIATED WITH META PLATFORMS, INC., AND TWITTER, INC.

1. HOW TO ENTER: **2024 Marvel Champions Campaign Contest** (“Contest”) is an email-only Contest. Contest begins at 12:00:00 PM (CT) on 4 November 2024 and ends at 23:59:59 PM (CT) on 25 November 2024 (this is the “Promotion Period”). The Contest announcements will be made via the Fantasy Flight Games website and on the Facebook, Instagram, and Twitter social media pages of Fantasy Flight Games. To enter, eligible entrants must follow the entry guidelines below during the Promotion Period (“Entry”). The email address to enter is: OrganizedPlay@FantasyFlightGames.com with the subject line: “Marvel Champions Campaign Submission.”

To Enter, Eligible Entrants must:

1. Choose three (3) to five (5) existing Marvel Champions scenarios.
2. For each scenario, choose which modular encounter sets will be included in the encounter deck.
3. Create a campaign document that lists each chosen scenario with its associated modular encounter sets, as well as any other information that will be tracked from one scenario to the next.
4. Include in your email the following information:
 - A. Your Full Name
 - B. Email Subject Line “Marvel Champions Campaign Submission”
 - C. Your State of Residence
 - D. Campaign Document, as reference in number three (3), above, as an attachment

All Entries become the property of Contest Entities. Any entrant who attempts to enter more than once for the Promotion Period, including by using multiple email accounts under multiple identities will be disqualified from participation in the Contest and all Entries from that individual will be considered void. Proof of submission will not be deemed to be proof of receipt by Contest Entities. Contest Entities are not responsible for any change of Instagram, Facebook, and/or Twitter account status, and/or email address changes.

2. ELIGIBILITY: Open to legal residents of the fifty (50) United States, the District of Columbia who are 18 years of age or older, or the age of majority in their state of legal residence at time of Entry who have an email address.
