

FANTASY FLIGHT GAMES USA FACEBOOK SWEEPSTAKES 34 OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. YOU MUST HAVE INTERNET ACCESS TO ENTER. SWEEPSTAKES IS IN NO WAY SPONSORED, ENDORSED, ADMINISTERED BY, OR ASSOCIATED WITH FACEBOOK, INC.

1. **HOW TO ENTER:** The Fantasy Flight Games Quiz Facebook Sweepstakes ("Sweepstakes") is an online-only Sweepstakes. Sweepstakes begins at 2:00:00 PM (CT) on May 3, 2022 and ends at 11:59 PM (CT) on May 8, 2022 (this is the "Promotion Period"). To enter, eligible entrants must comment on the Sweepstakes Facebook announcement post their answer to the week's quiz question ("Entry").

All Entries become the property of Sponsor. Limit one (1) Entry per person for the Promotion Period. Any entrant who attempts to enter more than once for the Promotion Period using multiple Facebook accounts, or under multiple identities will be disqualified from participation in the Sweepstakes and all Entries from that individual will be considered void. Proof of submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for any change of Facebook account status, email address, and/or telephone number of entrants.

3. **ELIGIBILITY:** Open to legal residents of the fifty (50) United States and District of Columbia who are 18 years of age or older at time of Entry who are registered members of Facebook.
