

2023 FANTASY FLIGHT GAMES SOCIAL MEDIA TRIVIA #67 CONTEST OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. YOU MUST HAVE INTERNET ACCESS TO ENTER. CONTEST IS IN NO WAY SPONSORED, ENDORSED, ADMINISTERED BY, OR ASSOCIATED WITH META PLATFORMS, INC. or TWITTER, INC.

1. **HOW TO ENTER:** The 2023 Fantasy Flight Games Social Media Trivia Contest #67 ("Contest") is an online-only Contest. Contest begins at 10:00:00 PM (CT) on November 28, 2023 and ends at 11:59 PM (CT) on December 3, 2023 (this is the "Promotion Period"). To enter, eligible entrants must comment on the Contest Facebook, Twitter or Instagram Contest announcement post ("Entry") with the correct answer to the trivia question.

All Entries become the property of Sponsor. Limit one (1) Entry per person, per designated social media platform for the Promotion Period. Any entrant who attempts to enter more than once for the Promotion Period using multiple social media accounts, or under multiple identities will be disqualified from participation in the Contest and all Entries from that individual will be considered void. Proof of submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for any change of Facebook, Twitter or Instagram account status, email address, and/or telephone number of entrants.

3. **ELIGIBILITY:** Open to legal residents of the fifty (50) United States and District of Columbia who are 18 years of age or older at time of Entry who are registered members of Facebook, Twitter, and/or Instagram. In the event of a dispute about the identity of the entrant, Entries will be declared made by the authorized account holder of the email address associated with the social media account on which the Entry is made.
